Funds used to purchase items from Great Floors LLC are from various departments. Annual spend is estimated to be approximately \$200,000.

**Consideration summary statement:**

City staff use Great Floors LLC to repair, remove, replace, and install flooring throughout the City. Great Floors LLC is an authorized reseller of the Mohawk Group and Mannington Commercial products from the cooperative contract.

A review of year-to-date transactions indicates that the City's total spend may exceed 100K. While no single transaction exceeds \$100,000, the City Purchasing policy requires Council authorization of awards greater than \$100,000.

The City has an Interlocal Agreement with Washington State Department of Enterprise Services that allows for purchases from its competitively awarded contracts in lieu of soliciting bids on our own.
