DETAILED SUMMARY STATEMENT:

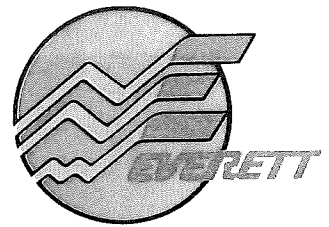
This project constructed pedestrian safety improvements on Pacific Avenue, from Rucker to Pine, and on Broadway, from 52nd St. SE to Hewitt Avenue. The improvements included increasing the visibility of pedestrians in crosswalks, improving traffic signal phasing, upgrading pavement markings, installing permanent radar speed signs and red light running police enforcement “telltale” lights at specific intersections.
