AN ORDINANCE concerning the City's Shoreline Public Access Plan, repealing Ordinance No. 2692-03

WHEREAS, the City Council adopted Ordinance No. 2692-03 on May 21, 2003, approving a Shoreline Public Access Plan (Plan); and

WHEREAS, the Plan does not need to be adopted by ordinance but instead can be adopted by resolution; and

WHEREAS, adopting and amending the Plan by resolution rather than by ordinance provides the City with more flexibility to timely address changed circumstances and unforeseen opportunities; and

WHEREAS, concurrent with this Ordinance, the City Council intends to adopt a revised Shoreline Public Access Plan by resolution and to amend the Plan from time to time by resolution.

NOW, THEREFORE, THE CITY OF EVERETT DOES ORDAIN:

Section 1: The City Council repeals Ordinance No. 2692-03.
