**Project summary statement:**

This project will install upgrades at the Casino Road & 5<sup>th</sup> Avenue W traffic signal. Upgrades include accessible pedestrian pushbuttons, flashing yellow left turn phasing, fiber optic connectivity, traffic monitoring cameras and lighting. Work also includes Americans with Disabilities Act (ADA) improvements in the project area.

**ORDINANCE NO.** \_\_\_\_\_

AN ORDINANCE creating a special improvement project entitled, "Casino Road & 5th Avenue W Pedestrian Safety Improvements" Fund 303, Program 117, to accumulate all costs for the improvement.

**WHEREAS,**

- A. The City of Everett is committed to a planned pedestrian safety program; and
- B. The City of Everett has identified the need and obtained funds to construct certain pedestrian safety improvements; and

**NOW, THEREFORE, THE CITY OF EVERETT DOES ORDAIN:**

**Section 1.** A special improvement project is hereby established as Fund 303, Program 117, entitled "Casino Road & 5th Avenue W Pedestrian Safety Improvements" to accumulate all costs for the improvement.

**Section 2.** Authorization is hereby given to accumulate costs and distribute payments from Fund 303, Program 117, for the improvement project.

**Section 3.** Authorization is hereby granted for the "Public Works Director" or "City Engineer," under direction of the Mayor, to assume full and complete responsibility for conducting all tasks and doing all things to accomplish the actions authorized in this ordinance.

**Section 4.** The sum of \$760,400 is hereby appropriated to Fund 303, Program 117, "Casino Road & 5th Avenue W Pedestrian Safety Improvements" as follows:

- C. This appropriation shall not lapse, but shall be carried forward from year to year until fully expended or the purpose has been accomplished or abandoned without the necessity of reappropriation.

**Section 5.** The City Treasurer of the City of Everett is hereby authorized to negotiate a reasonable rate of interest and obtain temporary financing to satisfy interim construction costs. Temporary financing shall be redeemed as soon as reimbursement is received.

**Section 6.** If any provision of this ordinance shall be declared unconstitutional or invalid by any court of competent jurisdiction, it shall be conclusively presumed that this ordinance would have been enacted without the provision so held unconstitutional or invalid and the remainder of this ordinance shall not be affected as a result of said part being unconstitutional or invalid.
