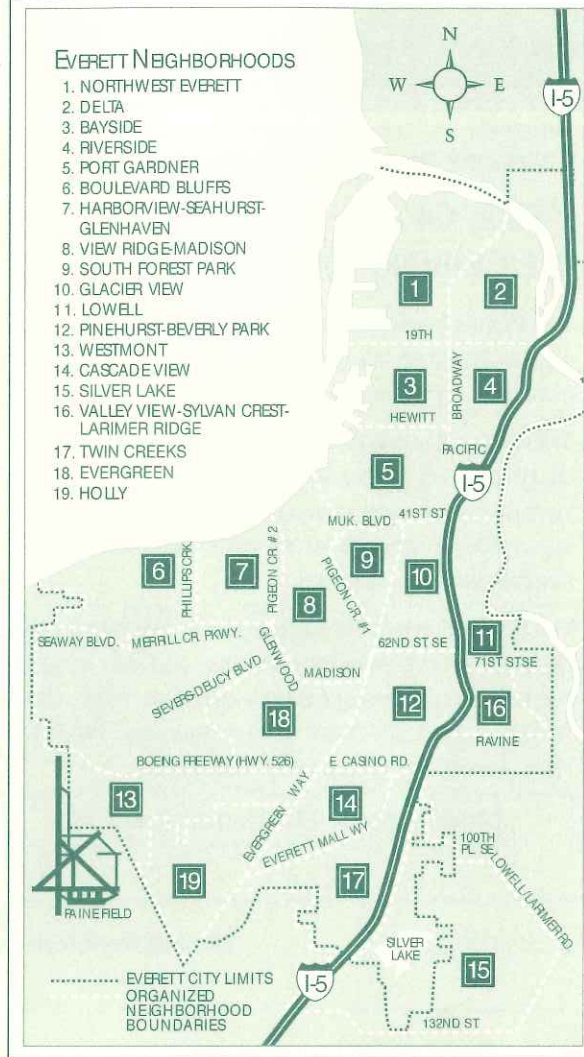

# NOMINATION FORM

## CATEGORY 1: REJUVENATION AND TRANSFORMATION



THIS AWARD IS FOR A RESIDENTIAL PROPERTY THAT HAS CHANGED FOR THE BETTER OVER TIME, WITH NOTICEABLE CHANGE THE PAST YEAR.

TO BE ELIGIBLE FOR THIS RECOGNITION THE NOMINATED PROPERTY WOULD HAVE BEEN TRANSFORMED, THROUGH A CONCERTED EFFORT BY ITS OWNERS OR OCCUPANTS, FROM A PLACE CONSIDERED A VISUAL LIABILITY TO ONE CONSIDERED A VISUAL ASSET.

THIS APPLIES TO PROPERTIES THAT HAVE BEEN UNNOTICED AND ARE NOW "SHOWPIECES", AS WELL AS REAL "EYESORES" THAT HAVE SIMPLY BECOME NICE-LOOKING HOMES. JUDGING WILL CENTER ON THE AMOUNT OF IMPROVEMENT AND NOT THE AMOUNT OF MONEY SPENT. HOMES BEING MARKETED FOR SALE ARE NOT ELIGIBLE.

## CATEGORY 2: PRIDE OF THE NEIGHBORHOOD



THE PRIDE OF THE NEIGHBORHOOD CATEGORY WILL BE AWARDED TO THE RESIDENTIAL PROPERTY THAT CONSISTENTLY LOOKS ITS BEST.

THESE HOMES SHINE WITH THE EFFORTS OF THE OWNERS OR OCCUPANTS WHO TAKE GREAT PRIDE IN THEIR PROPERTY AND WHOSE HIGH STANDARDS FOR HOME AND YARD MAINTENANCE CONTRIBUTE TO THE CHARACTER OF OUR NEIGHBORHOODS AND CITY.

THE WINNERS WILL NOT NECESSARILY BE THE HOMES THAT ARE THE BIGGEST OR MOST EXPENSIVE, BUT WILL REFLECT THE KIND OF LOVING ATTENTION AND CARE THAT MAKE THEM THE JEWELS OF THEIR NEIGHBORHOODS. HOMES BEING MARKETED FOR SALE ARE NOT ELIGIBLE.

## CATEGORY 3: NEIGHBORHOOD- FRIENDLY BUSINESS

THE NEIGHBORHOOD-FRIENDLY BUSINESS AWARD WILL BE GIVEN TO BUSINESSES THAT RATE HIGH IN OVERALL VISUAL QUALITY.

CONSIDERATION SHOULD BE GIVEN TO APPROPRIATE SIGNAGE, BUILDING DESIGN, MAINTENANCE AND LANDSCAPING.

THE BUSINESS AND BUILDING SHOULD FIT IN AND BE AN ASSET TO THE RESIDENTIAL PART OF THE NEIGHBORHOOD.

THIS AWARD RECOGNIZES HOMEOWNERS WHO HAVE IMPLEMENTED NATURAL OR GREEN GARDENING PRACTICES TO MANAGE STORMWATER RUNOFF AND CREATE A MORE NATURAL PLANTScape. NATURAL OR GREEN GARDENING PRACTICES ARE BASED ON THE PRINCIPLE THAT YOU CAN CREATE A VISUALLY APPEALING YARD AND SAVE TIME, CONSERVE WATER, PROTECT YOUR FAMILIES HEALTH AND PROTECT THE ENVIRONMENT AND LOCAL WATER QUALITY.

THE WINNERS OF THIS CATEGORY SHOULD BE ABLE TO MEET MANY, IF NOT ALL, OF THE FOLLOWING CRITERIA:

- ❖ VISUALLY APPEALING
- ❖ STORMWATER INFILTRATION PRACTICES
- ❖ DIVERSITY OF PLANTS
- ❖ SMART-WATERING TECHNIQUES
- ❖ MULCHED GARDEN BEDS
- ❖ RIGHT PLANT, RIGHT PLACE PRINCIPLES
- ❖ NO CHEMICAL PESTICIDES
- ❖ LESS THAN 60% OF YARD IS GRASS OR OTHER IMPERVIOUS SURFACES

WINNERS IN THIS CATEGORY WILL HAVE BEAUTIFIED THEIR YARDS, MAKING THEM AN ASSET TO THEIR NEIGHBORHOODS AND THE ENVIRONMENT.
